Cllr Skeats reported that a new highways officer would now be covering West Moors, on a large bonfire at Blackfield Farm and that DC enforcement at Dorset Council had been carried out.

25/230 TO RECEIVE TOWN CLERKS REPORT

- 1. Remembrance Parade was well attended and successful. However, prior to the event the Council had two advanced road closed notice signs stolen, this was reported to the police. Dorset Council kindly lent some of their signs to WMTC.
- 2. Men's Shed Members of the organisation have looked at land suggested by the Town Council. They have approached the Memorial Hall about the green space in the Memorial Hall car park, they are also very interested in the space at Fryer Field

between the MUGA and the end of the Memorial Hall car park and will be putting a proposal together to present to members in December.

- 3. Publicity response to the consultation results has been mainly positive.
- 4. Christmas decorations are all in place.
- 5. Carols on the Petwyn organised by the youth club will be held on Saturday 6th December. The Council office have received a few complaints about the change of day for this event; these have been passed on to the organisers.
- 6. At the January meeting of the Council, there will be a presentation on the Armed Forces Covenant which the Council can sign up to.
- Asset of Community Value: West Moors Library has met the requirements and has been listed as an Asset of community value. St Martins Church did not meet the criteria and has therefore not been listed.
- 8. A resident requested that the council consider a British Heart Foundation Book bank to be located somewhere in West Moors. They were informed that no space was available at the Par Way car park and they should speak to the Memorial Hall Council to see if they could accommodate one.
- Speed reduction: an email sent to Dorset Council requesting that they consider a 20mph limit outside St Marys school has received a reply stating that the Town Council has to abide by the same DC process for any 20mph limit reduction, such as demonstrating community support.

AGENDA ITEM 9 – Internal Auditor

Members are aware that Tim Light of Lightatouch is retiring after completion of the 2025/26 audit (once the AGAR has been signed off)

There is a shortage of internal auditors, however Tim has recommended Mulberry Local Authority Services Ltd for 2026/27

This company was contacted when WMTC were looking for a new auditor for 2025/26 (March 2025 F&GP committee).

They charge per hour instead of a set fee. The current cost for the internal audit service is £975

The hourly rate is £80 and they have stated that it should take between 5 and 8 hours. There is also an additional charge of 45p per mile for travel.

Mulberry Local Authority Property services are independent of West Moors Town Council and therefore meet the criteria set out in the Practitioners Guide 2025 for the appointment of an internal auditor.

It is recommended that West Moors Town Council appoint Mulberry Local Authority Services Ltd as their internal auditor for 2026/27
