Members were happy with the organisation of the event so far and asked that the advertising clearly state that the raffle prize money is being sponsored by local generous businesses, not the Town Council.

23/338 DORSET COUNCILLOR REPORT

There were no written reports provided by the Dorset Councillors, however members asked for a progress update on the pedestrian crossing request on Station Road by St. Mary's First School. Cllr M Dyer explained that he believes it to be at the top of the list, having had the feasibility study carried out and the next stage is planning the logistics of it.

23/339 INFORMATION FROM MEMBERS

Cllr Salt provided an update on the West Moors Community SpeedWatch initiative: 13 Community SpeedWatch sessions have been held at various locations in West Moors since the CSW began in November. During those sessions, approximately 6,763 vehicle movements have been counted with 84 vehicles (approximately 1.25%) being reported to the Dorset Police CSW Co-Ordinator for further action. The Dorset PCC have purchased a number of Automatic Speed Watch cameras which are currently under trial throughout Dorset. These new cameras continuously monitor vehicle speed during daylight hours, the West Moors CSW team have requested to be part of the trial and are awaiting further information from the Dorset CSW Co-Ordinator. The West Moors CSW Team need more volunteers. Office staff to advertise.

Cllr Way reported on his attendance at the latest Youth Club committee meeting and informed members on; upcoming plans to change sessions nights, grant training, current attendance figures, the film night previously carried out for 2 years running, will be replaced by another event, yet to be discussed and Youth Club constitution changes.
