# 25/158 QUESTIONS FROM MEMBERS OF THE PUBLIC

Resident had two queries about Blackfield Farm:

1. When will the mess left on the field be cleared?

Cllr Mrs Yeo suggested that was the responsibility of the landowner.

Cllr Mrs Holmes stated Dorset Council's enforcement team should be informed.

Officers to contact Dorset Council to chase enforcement on this issue.

2. Why can't Blackfield Farm be green belt land?

Resident suggested the land was serving its purpose as a buffer between SSSI land and urban settlement and should therefore be green belt. Resident suggested Dorset Council don't appear to be against it being green belt, and other options will be costly for them. Resident requested that the Council push Dorset Council for it to be made green belt.

Cllr Mrs Holmes queried who would be paying for the street light upgrade. Cllr Shortell to find out whether there is a grant from central Government for this scheme. It was also queried whether the new, more efficient lighting would reduce energy costs overall.

- 4. Dorset Council's aim to recover at least £1m lost through the mismanagement of a project set up to update and repair council properties
- 5. The draft plan aimed at how the Dorset National Landscape area is protected.

#### 25/167 LOCAL PLAN CONSULTATION

Members discussed the Dorset Council Local Plan Consultation and the specific sites for West Moors.

Cllr Mrs Yeo suggested all councillors write their own individual response.

Cllr Mrs Senior suggested the Council should be requesting that Blackfield Farm is put back into the green belt.

The Clerk advised there is a specific section on the survey where this can be requested. Resident asked that a specific Dorset Councillor and Officer are also written to about Blackfield Farm.

After some discussion, it was

RESOLVED that each Councillor submit their own response to the Dorset Council Local Plan Consultation with an emphasis on putting Blackfield Farm back into the green belt. Officers will write an official response, ensuring the specified Councillor and Officer at Dorset Council are notified.

#### 25/169 INFORMATION FROM MEMBERS

Cllr K Wilkes reported on the Dorset Council Leisure Facilities Strategy. Members discussed how we can help to bring together and promote leisure facilities in West Moors. It was suggested Officers could contact various venues in West Moors to get regular listings and advertise these clearly on our website.

Cllr C Way gave a report on the Youth Club. Their refurbishment is almost complete, they are doing well on their budget and are busy.

Cllr Mrs Holmes suggested Councillors and officers get together for a Christmas lunch.

Cllr D Shortell praised the recent refurbishments at Pinehurst Community Church.

Cllr J Staig raised concerns in light of the Dorset Councillor report on new street lighting that lights should not go off at night. The Clerk clarified that only street lights on Station Road and Pinehurst Road should stay on all night, and any other lights that remain on after midnight should be reported to Enerveo via the Dorset PFI Lighting Portal.

Cllr Mrs Yeo reported on recent activities by the West Moors Dementia Action Group, in particular that they are looking into having their own dementia-specific Admiral Nurses, but noting this will be extremely costly. Cllr Yeo also reported that she and Cllr Mrs Burke had attended a recent Business Breakfast at Brook View Residential Home and had found it a useful opportunity to network.
